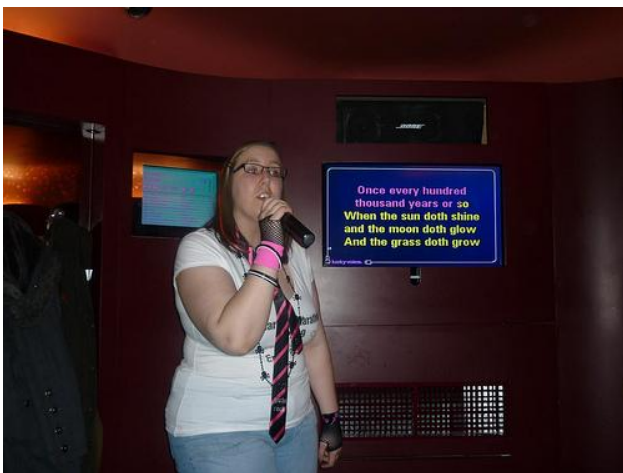
JFK's CHARITY KARAOKE MARATHON

YOUTH ADVOCACY

Recently, our Youth Advocate, Ernestina Amanfo was asked to assist Daniel (13) who had brought a knife

into school and used it to threaten another student. Daniel was

at risk of permanent exclusion because of this incident. Ernestina spoke to Daniel about the incident and what had led him to bring a knife into school. Daniel informed Ernestina that he had been bullied and beaten up by the student for two years and the student had pulled a knife on him. Daniel felt he had no other choice but to bring the knife into the school to protect himself. He had no intention of using the knife. Daniel's father informed Ernestina that his son had a statement of special educational need and felt that his son was not obtaining the necessary support from the school. Ernestina assisted Daniel at the Governor's Disciplinary Meeting. The Governor's were informed of the history between Daniel and the student, the ongoing bullying and that an emergency/interim review of Daniel's statement of educational needs should be undertaken. The school agreed that this was the appropriate remedy offering mediation and allowing Daniel to remain at school.

LEGAL REPRESENTATION

Richard, sixteen years old, had spent time in prison before but when he was locked up this year it was at an extremely traumatic time in his life. Richard's girlfriend had just miscarried and he blamed himself and desperately wanted to be there to support her. Richard started self-harming in the cells in Court, tearing at his skin on his arms stomach and face with his own nails, a doctor was called and he was sedated. Due to our concerns we made representations to the Court that Richard was vulnerable and should not be detained in prison, his own Youth Offending Team refused to support our application on the basis that he had been able to cope with prison before. Despite the Youth Offending Team objections the Court agreed with us; Richard was found to be vulnerable and was placed in a small unit with only 20 boys. His Youth Offending Team informed us that they would not allow him to stay there when he turned seventeen and he would be transferred to prison. Luckily the day before his seventeenth birthday we made an application to the Court to dismiss his case due to insufficient evidence, we were successful. Richard was released to go home with his girlfriend and family all of whom were waiting for him outside Court with balloons. Without our specialist knowledge Richard would have spent that time in prison, with no proper care, he would have continued to self-harm and could have suffered long term psychological damage.

TRAININGS

Just for Kids Law and Prison Reform Trust's Out of Trouble program have partnered to provide specialist trainings across the country to lawyers representing

children and young people in criminal proceedings. It has

long been an aim of JfK that children in criminal proceedings are provided with specialist representation. There is currently no requirement for lawyers to have any kind of additional training to represent children and young people, despite the different legislation and body of case law. What is unique about our training is that as well as informing about the law we use our kids as trainers. We have been providing our training for a number of years to various chambers and law schools but now, thanks to Prison Reform Trust, the training will be rolled out nationally. Trainings will take place from March to September next year and will be in; Birmingham, Bristol, Cardiff, Hull, Ipswich, Leeds, Liverpool, London, Manchester, Newcastle and Nottingham. Dates will be advertised on our website in the New Year.

SPREADING THE MESSAGE

In September our board member Maya Sikand and director Shauneen Lambe presented a seminar on at Garden Court Chambers Children's Rights Day, in celebration of the Twentieth anniversary of the UN Convention of the Rights of the Child. The seminar covered the rights of children in criminal proceedings to effectively participate in their trials and how to identify and litigate the issues of fitness to plead and effective participation.

Meanwhile co-director Aika Stephenson was spreading the message to young people in Luton when she gave a talk at Starlight Youth Club about our work.
